Overview

Literature has always been fascinated and influenced by technological innovation, even if, with the exception of printing technology, only digital devices, software, applications have provided writers with new writing surfaces (screens, human bodies, landscapes ...) and new narrative praxis.

Electronic literature is a contemporary art form that experiments with modes of writing in the digital environment. Because of its innovative nature, eliterature can be seen in the wake of Laurence Sterne, Stéphane Mallarmé, Tristran Tzara, William Burroughs, Futurism, Dadaism, Concretism ... that is to say all those writers and movements interested in the deconstruction of both the printed page of the book and the linear writing/reading process. "E-literature" refers to those literary texts which require the computation performed by a digital device in order to be written as well as to be read. With the development of Information Technology (IT), e-literature has turned into a fertile ground for experimentation with new cognitive models, and now it encompasses, to name just a few examples, hypernarrative, cyberpoetry, database fiction, social media storytelling, locative narratives, twitterbots, as well as forms of narration in virtual and augmented reality.

More than the process of telling the story of a character who acts in time and space, the expression "digital storytelling" refers to the design of a narrative and interactive experience. The human-machine interaction, technically defined by an algorithm, guides our communicative practices in daily life, therefore e-literature can be seen as both a challenge to traditional linear narration, and a means to become aware of new normative expectations in digital communication.

A critical overview of electronic literary works will introduce participants to different types of writing praxis, so that they can understand the languages of technology (techno-logic) as well as develop a critical thought that can effectively orient on the global trends of digital storytelling.

Objectives

The primary objectives of the course are as follows:

- Providing of a new form of literary expression;
- ii. building awareness about the importance of the writing and the reading "process" in digital communication;
- iii. exposing participants to the fundamentals of digital argumentation;
- Iv. enhancing the capability to recognize different communication models enacted by digital technologies.
