

## REGISTRATION PROCESS

In the first stage, participants are required to register online at GIAN portal- <http://www.gian.iitgkp.ac.in>. ## SCOPE OF THE PROGRAMME

Global Initiative of Academic Networks (GIAN) is a program launched by Ministry of Human Resource Development (MHRD), Government of India, with the objectives of recruiting the talent pool of scientists and entrepreneurs, internationally to encourage their engagement with the institutions of Higher Education in India. To this end, a one-week course on "Human Trafficking in the 21<sup>st</sup> Century" has been approved by MHRD, under this program which is being organized by the Department of Criminology and Forensic Science, School of Applied Sciences, Dr. Harisingh Gour Vishwavidyalaya (A Central University) Sagar, Madhya Pradesh, India.

## ABOUT THE COURSE

Human Trafficking has been described as the world's fastest growing criminal activity and the second most profitable crime after illegal drug-trading. Human trafficking is also considered one of the worst human rights violations. In 2017, the International Labour Organization estimates that almost 25 million people are victims of this 'modern day slavery'. Some of the main types of trafficking include: prostitution, forced labour, child soldiers, organ removal, debt bondage, and forced marriages. Trafficking in persons (TIP) is a unique crime as it is recognized as both a domestic and transnational crime in nature. In fact, no country is immune from the plight of human trafficking and in reality; this is one of the major concerns of the 21<sup>st</sup> Century with the increasing ease of movement, mobility, and expanding free-trade under the shadow of globalization. TIP is also one of the few crimes that have been pursued from a victim's perspectives with a focus on prevention of trafficking, protection of victims, and prosecution of traffickers. Since the United Nations 'Palermo Protocol' came into force in 2000, there has been a dramatic increase in awareness and in an effort to combat the plight of TIP. The academic community has also embraced this issue and a growing number of scholars are using evidence-based research to better inform local, national, and international response protocols. However, to-date, there is no universal mechanism that adequately inform our responses to this issue. Therefore, a comprehensive course on the subject is needed to help bring the best current knowledge, range of expertise, and various specialists to engage in a one-week course on how to effectively and efficiently combat the trafficking in persons.

## ABOUT THE FOREIGN FACULTY



In 1988, Professor John Winterdyk became the first Canadian to obtain a PhD in Criminology from the prestigious Simon Fraser University in Vancouver, CANADA. He studied under some of the notable criminological luminaries such as: Professors Ezzat Fattah, Paul and Patricia Brantingham, Ronald Roesch, Ray Corrado, Leslie Wilkins, among others. Being a newly minted PhD student with no real job market for criminologists in Canada, he moved to Calgary to help enliven their modest criminal justice program. Although not planning to stay long, he had spent his entire academic career working at Mount Royal University. He was instrumental in helping to evolve their a two-year diploma into a Bachelor of Arts Degree, served as Department Chair, established their first Criminological Research Centre, twice been an invited honorary Endowed Chair at St. Thomas University (CANADA), and has held several Adjunct positions throughout the world. He has been a frequent Visiting Scholar at the prestigious Max Plank Institute in Freiburg, GERMANY and has given invited lectures/talks in over 25 countries. Professor Winterdyk has become one of the most recognized names in Criminology in Canada today. To-date he has authored/edited over 30 academic books and a notable number of peer reviewed articles. In 2010, he became the first recipient of the Mount Royal 'Distinguished Scholarship Award' and in 2018 was nominated as the most 'Distinguished Scholar' in his faculty (announcement to be made in March 2019). In 2003 he was involved in a major research project funded by the National Institute of Justice in the United States where he and his co-investigators explored best practices in combating human trafficking. Since then he has been involved in a variety of subject related studies and projects, and edited four special journal issues on human trafficking, edited two academic books on human trafficking, and is currently working on the first Major Reference Work on human trafficking (Palgrave Pub.) which will include over 90 international entries that are grouped into eight major sections.

## WHO CAN PARTICIPATE

This course is intended for undergraduate, post graduate students, research fellows, as well as faculty members of academia from a wide range of disciplines; including law, criminal justice, criminology and forensic science, social work, nursing/health care, etc. In addition, the course will also be value addition to criminal justice officials and practitioners (e.g., lawyers, law enforcement, and border security personnel). Furthermore, front-line workers and NGO's may also find this opportunity as an invaluable learning experience. Finally, the course is also open to Officers/ Executives/ Researchers from various organizations of Indian Government.

## HOW TO REACH

Sagar (Saugor: SGO) is a focal point of two national highways and many state highways. It is about 190 km from Bhopal on the state highway, about 200 km from Jhansi on NH26, about 180 km from Jabalpur on state-highway, about 70 km from Bina. Sagar is situated between Bina-Katni section on the rail map, 75 Km from Bina Junction and 188 Km from Katni Junction. Nearest airports with regular domestic flights are at Bhopal, Jabalpur and Khajuraho. It takes 3–5 hours by road to these airports.
