Apprehending contemporaneity: A globalised gaze upon Postcoloniality and Diaspora through Chimamanda Adichie's literature

Overview

This course departs from the premise that there is an evident necessity to better understand the world in which we live. Since most nation-states in the World System (WALLERSTEIN, 1974) were once colonies, it becomes crucial to theorize and discuss the consequences of Coloniality that persist in the 21st Century. How does colonial oppression continue after colonisers leave? Why is decolonisation difficult to be consolidated, even after political independence? This course proposes to enable its participants' critical view towards possible answers to these questions, as readings and debates intend to lead to the understanding of participants' own selves and societies through comparison. To achieve this goal, concepts will be studied and applied to literary representations of postcolonial individuals and communities.

Theoretically speaking, there will be a focus on concepts such as, Globalisation, Postcoloniality and Diaspora. Their study leads to what I call "Cultural Decolonisation", i.e., a repositioning of postcolonial individuals and societies that seek to deal with the effects of colonial cultural oppression in their minds, spirits and imagination (BRAGA, 2019). Such repositioning often takes place in experiences of mobility. Therefore, the course will also focus on the diasporic facet of our present condition named Postcoloniality. Currently represented in literature, Postcoloniality is a condition characterised by intense negotiations originated in processes of direct colonization comprising rejection, acceptance or reappropriation of values left by colonisers (BRAGA, 2019).

The approach to the concepts mentioned will be made from the analysis of stories written by worldwide known, award-winning Nigerian writer Chimamanda Adichie, enriched with illustrations from Brazilian culture. Since Nigeria, Brazil and India went through colonisation in the past, the course will provide a substantial comparative framework to Indian participants

Braga's interests lie in exploring new approaches to the representations of Postcoloniality, cultural decolonisation and diasporic mobility. He received his doctoral degree in Comparative Literature in 2010 (UFMG/Brazil), having done part of his PhD research in the University of California at Santa Cruz (UCSC) in the previous year. In addition to teaching and advising at UnB, Dr Braga organizes academic events, takes part in national international conferences, and is a co-investigator in the Mayombe Research Group, having published articles in Brazil and abroad.
